



Spirit of Giving Campaign Rules:

Airco Heating and Cooling Ltd. will conduct a “**Spirit of Giving**” campaign substantially as described in these rules and by participating, each participant agrees as follows:

1. **Description of “Spirit of Giving”:** The purpose of “**Spirit of Giving**” is to find needy, deserving homeowners who reside in the Fraser Valley within Airco Heating and Cooling’s service area and their current heating system is old and needs help.
2. **Dates of “Spirit of Giving”:** “**Spirit of Giving**” nominations will kick off on Dec 1 2019, and will end at midnight on Dec 31, 2019. One winner will be announced and notified by Jan 16, 2020.
3. **How to Submit a Deserving Recipient:**
 - a. Applications can be submitted in one of 2 ways:
 - i. By visiting our website at www.aircoheating.ca/spiritofgiving (fill out online and submit).
 - ii. By completing the nomination form (which can be requested by mail) and submitting by mail to our address above or dropped off at our office located at the same address.
4. **How the Winner is Chosen and Announced:**
 - a. A 4-member committee will select the winner from the nominations received and the winner (recipient) will be announced and notified as soon as possible after.
 - b. If the winner (recipient) cannot be contacted within 48 hours of the announcement or it is determined by Airco Heating and Cooling that the selection does not qualify, committee reserves the right to determine an alternate recipient.
5. **Gift:**
 - a. One new Daikin gas furnace heating system, with thermostat (does not include duct work) will be awarded to the eligible recipient:
 - i. One new heating and air system will be installed by Airco Heating and Cooling at the winner’s (recipient’s) home.
 - ii. Installation to be performed during normal business hours and is based on Scheduling availability.
6. **Eligibility and Limitations:**
 - a. Participants must be Canadian residents, and reside in the Fraser Valley within the Airco Heating and Cooling Ltd. service area, be at least 18-years old, be the owner of the home

on the application, must be living in the home, and must prove that they are deserving of a new heating system.

- b. Each recipient must submit proof of eligibility and home ownership.
 - c. Employees of Airco Heating and Cooling Ltd. and members of the immediate family of any such persons are not eligible to participate and win. The term “immediate family” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriages(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.
7. **Publicity/Use of Personal Information:** By participating, all participants and recipient(s) grant Airco Heating and Cooling Ltd. exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion and waive any claims to royalty, right, or remuneration for such use. By participating in “**Spirit of Giving**”, participants agree that Airco Heating and Cooling may disclose personal information obtained from participants in “**Spirit of Giving**” to third parties and use such information for communication and other purposes.
 8. **Release:** By participating, each participant and recipient waives any and all claims of liability against Airco Heating and Cooling Ltd, its employees and agents for any personal injury or loss which may occur from the conduct of, or participation in, “**Spirit of Giving,**” or from the use of any awarded system. In order to receive a system, participants must sign an official waiver form provided by Airco Heating and Cooling Ltd.
 9. **Decisions:** By submitting an application in “**Spirit of Giving**”, participants agree to be bound by the decisions of Airco Heating and Cooling Ltd. personnel. Airco Heating and Cooling Ltd. reserves the right to disqualify any participant and may refuse to award a system to a person who is ineligible or who Airco Heating and Cooling Ltd believes has violated any rule, gained unfair advantage in participating in “**Spirit of Giving**”, or obtained winner status using fraudulent means. Airco Heating and Cooling Ltd. will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules; and Airco Heating and Cooling’s decisions concerning such disputes shall be final. If the conduct or outcome of “**Spirit of Giving**” is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of Airco Heating and Cooling Ltd, Airco Heating and Cooling Ltd. reserves the right to terminate “**Spirit of Giving**”, or make such other decisions regarding the outcome as Airco Heating and Cooling Ltd. deems appropriate at any time during “**Spirit of Giving**”.
